## **Notification of Risk**

These risks include loss or damage to personal property, and injury or fatality due to inclement weather, slipping, falling, insect bites, falling objects, or suffering any type of accident or illness in remote areas without easy access to medical facilities. I acknowledge that all associated dangers cannot be foreseen.

## **GUIDELINES**

- We agree to maintain a wholesome atmosphere by refraining from vulgar language, dress, and actions that would detract from a Christian environment.
- We understand that alcoholic beverages, tobacco products, glass bottles or containers, illegal drugs, fireworks, firearms, or pets, (and any other weapons) are not permitted on Doe River Gorge property.
- We understand that due to potential hazards, children under age 18 are not permitted on the premises without safety conscious adult supervision and signed consent, that no one is permitted on the trestle bridges at any time, and that hiking is not permitted along the railroad bed during *Day Quest*.

## **INDEMNIFICATION**

We hereby release and discharge Doe River Gorge, its officers, directors, employees and agents (collectively "Doe River Gorge") from any claims, causes of action, costs, obligations or financial responsibility resulting from or arising out of any incident, injury or accident occurring to any participant registered with our family/group while attending Doe River Gorge. If Doe River Gorge is held financially responsible for any such incident, injury or accident, we agree to indemnify and hold Doe River Gorge harmless from any such responsibility, including costs, damages and attorney fees incurred by Doe River Gorge. We further agree to provide supervision and control over all participants with our group and will be responsible for providing or securing any necessary medical treatment, transportation or care which might be necessary for them.
